## **CHAIRMAN'S REPORT**

• FY22 Audit Report

Mr. Roselli presented the FY22 School District Audit Report. Mr. Roselli reported that Mrs. Sharek and her team did a great job, with no audit material weaknesses. He reported cooperation from the Management and the Business Office staff for completion of the Audit. No findings were identified and the overall financial position of the District remains strong.

### SUPERINTENDENT-DIRECTOR'S REPORT

• Out of State Field Trip – Metals Program-Cumberland, RI (Appendix 2023-16)

Committee members were presented with a request from the Metals program to bring students on an out of state field trip to Cumberland, RI, to visit the Tiffany & Co. Manufacturing Facility. The field trip is to take place on March 10, 2023. Superintendent Evans reported this is a great opportunity for our

## • Facility Update

Superintendent Evans updated the Committee on the status of the modular construction. Superintendent Evans reported that we finally got resolution of the issue with the sprinkler system to the satisfaction of our attorney and we have gotten the go ahead for the project. The area has been roped off and two of the buildings have been delivered and are in the process of being installed and assembled. Superintendent Evans said he expects this to happen in a timely fashion and we will have some useable space very soon. He said depending on when they are ready, we will make a decision if we should make use of the modular classrooms as soon as possible, or if it makes more sense to move people at the start of the new school year. Superintendent Evans said that when the modular are ready he will offer a tour to the Committee as he did with the HVAC program.

## Municipal Meeting Update

Superintendent Evans reported that he presented our request for a Capital Stabilization Account to the Finance Committee of the Framingham City Council, and they referred it to the full City Council. The City Council did have their meeting and approved our request. We still are in the process of scheduling with our other four towns. At this point in time, we have a meeting scheduled on March  $22^{nd}$  with the Natick Education and Learning Sub-Committee and a meeting with the full Finance Committee in Natick on March  $30^{th}$ . We are expecting to hear from Ashland, Holliston and Hopkinton with dates to present. As soon as we have the information, we will send it along to the appropriate Committee members. We also expect that we will receive a date to present to the Framingham Finance Committee in regards to the FY24 Budget. Superintendent Evans reported that we continue to get respect and accolades regarding our process of line by line review of our budget. He reported that as always, he thanks our sending communities for a great relationship and the willingness to send students to visit us at Keefe Tech.

# • Update on Program License

Superintendent Evans reported that our efforts regarding the hoisting credentialing has been a long and frustrating process. Superintendent Evans said we continue to be compliant but continue our efforts to get students credentialed. Superintendent Evans reported that we have completed 18 DOT physicals. He reported that we have funded this process by doing the physicals here at Keefe Tech. He said the next step is for students to test their knowledge on regulations and laws in the state. Superintendent Evans reported that the instructors has gone through this process so they can help to prepare students. Superintendent Evans said that unfortunately, some of our sister schools are now being shut down as well. He said this is bad for students, and this whole process does not make a lot of sense. Superintendent Evans said that there are three hoisting bills going before the state. He said he has reached out to Representative Jack Lewis who has co-sponsored all three bills. He reported that he hopes there might be a path forward with the new Secretary of Labor and Workforce Development. Superintendent Evans said we are all about offering authentic experiences for students and teaching them safely under 18 years old before they leave us. He said that any one of us could go out and rent hoisting equipment without any training and this doesn't make sense considering our instructors are licensed in this area and can oversee students safely so they are prepared when they leave Keefe Tech.

Superintendent Evans explained that school choice would be a very unpopular decision with our member municipalities that are paying substantially more, considering we have a waitlist for in district students. There will be a public hearing on School Choice at the April meeting.

Superintendent Evans reported that he was very pleased that the significant increase in State Aid, will lead to a smaller overall assessment increase than expected.
